#### Nebraska Child Abuse Law

Nebraska State Statute 28-707 / 28-710

A person commits child abuse if he or she knowingly, intentionally, or negligently causes or permits a minor child to be:

- 1. Placed in a situation that endangers his/her life or physical or mental health
- 2. Cruelly confined or cruelly punished
- 3. Deprived of necessary
  - Food
  - Clothing
  - o Shelter
  - o Care
- 4. Left unattended in a motor vehicle if minor child is six years or younger
- 5. Sexually abused
- 6. Sexually exploited by allowing, encouraging, or forcing such person to solicit for or engage in
  - o Prostitution
  - Debauchery
  - o Public Indecency
  - o Obscene or pornographic photography, films, or depictions

#### Why do some people not report to CPS?

- Little training
- Identification with the family
- Fear of reprisal
- Reluctance to interfere
- Perception that treatment failed / "lost cause"
- Results from prior CPS reports
- Fear of being wrong

# How to Appropriately Respond to Child Abuse

Initial response

- Do not over-react: Be calm, do not rush to an emotional state, and remember you have the full support of the agency.
- Offer encouragement: Let your Little know that you are proud of them for talking about this with you. Utilize "I statements." Let them know they are free to continue talking.

Example: "Wow. That took a lot of courage to tell me that. I'm glad that you value our friendship as much as I do."

If asked for immediate advice or guidance: Do not feel obligated to answer immediately. Ask if they will allow you a little bit of time to think things over and talk about it later, but give them a specific time frame.

#### Don'ts:

- We must be sure to not confuse the child or alter the story.
- Do not pressure for information or ask leading questions.
- Do not ask "why" it occurred (infers blame) or judge their behaviors.
- Do not first contact the Parent/Guardian (reports must go directly to CPS or BBBS).

#### **Minimal Facts Questions**

CPS will expect you to have gathered these basic facts:

- "What happened?" "When did it happen?" "Who did it?" "When is the next time you will see them?"
- Let them know they are safe with you and assess their current level of safety.

#### Talking with Big Brothers Big Sisters of the Midlands

- If you feel you need to talk with a staff member before calling CPS, please call us. We can offer emotional support and guidance.
- You will need to be the reporter to CPS. We cannot call CPS for you. We will help you gather the needed information to call CPS.

#### Talking with Child Protective Services

- They will want to know names, birthdays, addresses, family details, match history, etc.
- They will want "the story:" what happened, who said what, who observed what, etc.
- If you do call CPS, you will need to notify us immediately.
